Re: Business for Approval

5(a) Accessibility upgrades

In regard to the modifications to the front entranceway and washrooms to meet accessibility requirements, 3 quotations have been received and copies have been provided to the Board. Staff are recommending the lowest quotation of the three, provided by Vertec Contractors Limited at \$73,715 plus HST. As Vertec has already been awarded the contract for replacing windows, insulating the exterior and siding, the additional work will be more easily coordinated with a single contractor.

By way of additional information, an application will be submitted for a grant of up to \$50,000 for these modifications, making the net cost to the Conservation Authority more affordable.

Recommendation: That the LTVCA accept the quotation of Vertec Contractor's Limited for modifications to the entranceway and washrooms, in the amount of \$73,715 plus HST, and that staff be authorized to submit an application for funding of the modifications.

A meeting of the Personnel & Finance/Executive Committee of the Lower Thames Valley Conservation Authority was held on Thursday, April 2, 2015 at the Authority's Administration Building at 100 Thames Street, Chatham, Ontario at the hour of 3:30 PM. A roll call was held with the following committee members present: J. Kavelaars, L. McKinlay, H. MacDonald, S. Caveney & R. Doane.

Also present were the following staff members: Don Pearson, Jason Wintermute & Valerie Towsley.

Chair John Kavelaars called the meeting of the Personnel & Finance/Executive Committee to order at 3:30 PM. He requested the members to disclose any conflicts of interest. None were declared.

Hearing #1/14 - CA Application No. 25-2014 - Watterworth

Jason Wintermute, Water Management/GIS Specialist provided the Committee with an update on the Watterworth file noting that the pretrial date had been set for May 24th, 2015.

Hearing #3/13 – CA Application No. 87-2013 – Drexler

Jason also informed the members that the Drexier file that went before the Hearing Committee for a change in the house plan layout was submitted to the Mining and Lands Commission by the proponent in objection to the Hearing Committee's decision on January 27th, 2015 to not approve the roofline extension towards Lake Erie. Staff are in the process of gathering files and information for submission to the Mining and Lands Commissioner.

Hearing #1/13 – CA Application No. 3-2013 – Neufeld

The Hearing Committee was given a brief update on the modifications proposed by Mr. Neufeld to his house plan layout that was approved by the committee on September 17th, 2013.

1. R. Doane - L. McKinlay

Moved that the modifications as submitted by Mr. Neufeld on January 30th, 2015 to reduce the overall footprint of the structure and to raise the basement floor to a higher elevation be approved.

4. Decision by staff on submissions with prior approval from the Executive Hearing Committee

Occasionally a proponent will return to staff with alterations to their proposals that had originally gone before the Executive Hearing Committee for approval. In most circumstances the alteration is minor in nature and would not impact the outcome of the Hearing Committee decision as the hazard would not be increased by the proposed change. It is staffs position that if the change is minor in nature, does not intrude further into the hazard in question, or lessens the potential of the hazard i.e. reduced foot print, raising a structure higher than originally proposed, or moving further away from the hazard, then it can be deaft with at staff level instead of the issue being brought back before the Hearing Committee.

Moved that if proponents come forward with an amendment to a prior Hearing Committee approved application, that the amended application can be approved at staff level so long as the modifications proposed by the proponent result in the reduction and/or elimination of the hazard risks.

A meeting of the Lower Thames Valley Conservation Authority's (LTVCA) Joint Health and Safety Committee (JHSC) was held Wednesday, April 1, 2015. Committee members present were: R. Dysarz, V. Towsley, M. Buttenham and A. Vriends.

1. Working at heights

- Currently no training providers
- Current employees are grandfathered until 2017 (Bruce, Mike, Russ & Gary)
- New employees need to take the course before they are allowed to climb heights
- Jason and water sampling crew? Not sure they need it or not (falling into water Section 26)
- Height minimum required falling more than 3 metres
- Bruce would be the competent person for training staff as per Section 26.2 of O.Reg. 213/91

2. Who is a Supervisor under OHSA

- The definition has been clarified in greater detail
- LTVCA followed the new model for training so are covered
- Staff need to reinforce who the site supervisor is for summer student positions
 Site Supervisor Someone has to be in charge at a worksite. e.g. 2 JCP working on own or 2 summer students working on own. At the start of the day, they must determine who the site supervisor is for that day.

MOL – can ask an employee at any time who is

- the Site Supervisor and
- who is your Direct Supervisor

Supervisor vs Site Supervisor

• TWO different things.

- Unpaid students, learners and trainees MUST receive the Basic OH&S Awareness Training for Workers
- Volunteers participating in one-off projects / events are not currently included in this definition

- June 1st commencement
- June 2017 is when we need to be completely compliant with all our materials

- WHMIS sheets need to be obtained and kept in the shop, in the hazardous materials building and in the field (in vehicle)
- Need to ensure all staff who handle chemicals have the proper safety equipment
- Need to update task procedure sheets accordingly

Re: Water Related Issues, Initiatives & Activities

i. FLOOD EVENT

For the second year in a row, the Lower Thames watershed experienced an unusually cold and snowy winter, followed by a rather orderly spring thaw with no significant flooding events.

On March 13th, ice measurements conducted by the Authority measured around 18 inches of ice thickness at the mouth of the Thames River at Lighthouse Cove and around 15.5 inches at the boat launch at Jeannette's Creek. Ice measurements are also typically taken at Thames Grove in Chatham but on March 13th the ice at that location no longer appeared safe. Previously, on February 11th there was 12.5 inches. Historical records have shown that there typically needs to be around 12 inches of ice at the mouth to create significant ice jams. There was actually more ice on the river this year than during the major flood years of 1981, 1984 and 1985. Consequently, the Authority was preparing for the potential of ice jam related flooding.

On March 14th, a snow melt event caused flows on McGregor Creek to rise enough to require the closing of the Rivard Dam and the operation of the Diversion Channel.

Over the next several days, water levels on the Thames River slowly rose and the ice cover degraded. By the night of the 18/19th the ice began to break up and minor ice jamming caused water levels to rise in the Thamesville area causing flooding of the low lying areas adjacent to the river. By the morning of the 20th, the ice had moved downstream of Prairie Siding and the ice accumulation was causing elevated water levels in the area. Although the Authority received a few phone calls from concerned residents, the flows on the river would not suggest any risk of flooding. On the evening of the 20th, the river opened up all the way to the mouth and the risk of ice jam related flooding passed for the year.

While there had been a significantly greater risk of ice jams and flooding this year, the Thames River watershed experienced ideal weather conditions to minimize the risk. During the melt period, the watershed had no rainfall and while temperatures rose during the day to melt the snow and ice, they dropped back near freezing at night to keep the melt event slow and gradual.

ii. WATERSHED MONITORING

a. Groundwater Station Installations

The Lower Thames Valley Conservation Authority has partnered with the Ontario Ministry of the Environment and Climate Change on the Provincial Groundwater Monitoring Network. Under that partnership, the Ministry provides equipment for the program and water quality analyses while the Conservation Authority provides staffing. Previously, many PGMN stations were equipped with telemetry equipment that allowed the ministry to call up the gauge station to download the data rather than requiring CA staff to drive out to the station and download the data. Due to recent changes in the Bell phone network, that telemetry system ceased to function. As part of a pilot program in partnership with the Ministry of Natural Resources and Forestry, the Ministry of the Environment and Climate Change has provided 3 GOES satellite based telemetry systems. CA staff installed those systems in early April and are just waiting on feedback from the MNRF to ensure the software is properly configured for the satellite uplink.

b. Surface Water Program

For several decades now the Lower Thames Valley Conservation Authority has partnered with the Ontario Ministry of the Environment and Climate Change on the Provincial (Stream) Water Quality Monitoring Network. Under the program, the Conservation Authority provides staffing to conduct sample collection and the Ministry provides the laboratory analysis. The Authority is currently supplementing the existing program by paying for biological analysis at the PWQMN sites. Currently, Jessica Schnaithmann is managing the program for the Authority.

There has been an increased demand recently for increased watershed monitoring in the watershed. The Ministry has asked the Conservation Authority to collect additional samples in order to analyze for pesticides and will be further adding to that program to address neonicitinoids. The current PWQMN program does have enough sites to cover all the subwatersheds in the Watershed Report Cards. There has been recognition that water quality sampling should be conducted when flows are elevated from rainfall events and this would require the Authority to alter its sampling schedule and add additional sampling days. The Ministry of Natural Resources and Forestry has asked to partner with the Authority for increased watershed monitoring in Rondeau Bay. (There are currently no PWQMN stations in the Rondeau Bay watershed.) It has been suggested that watershed monitoring in the Lower Thames needs to be expanded in order to properly assess nutrient loadings from the Thames River as part of Canada's commitment to the Great Lakes Water Quality Agreement. There has also been a suggestion that increased water quality sampling is required to address the Blue-Green Algae issue. In some cases, questions are being asked about the effectiveness of stewardship activities for improving water quality which can only be addressed by water quality monitoring. In addition to its own interests in water quality, the Conservation Authority is seen as an obvious partner by upper levels of government based on previous PWQMN activity. Staff will be reviewing our water quality monitoring program, staff capacity and sources of funding in the near future in light of these developments.

c. Vandalism at the Chatham Gauge

Overnight on April 5/6, the municipally owned property at 300 Grand Avenue East in Chatham was broken into and vandalized. The municipality is no longer using the facilities and has deemed the property surplus so the property isn't as well monitored as it used to be. The Conservation Authority has an interest in this property for several reasons. The Conservation Authority continues to use the greenhouses at the property for their stewardship activities. Also located on that property is a water level gauge used for flood warning and management purposes. It appears that there wasn't any damage to the greenhouse area. However, sometime between 6:00 am and 7:00 am, the gauge itself was vandalized.

The gauge is managed under a partnership agreement between Water Survey of Canada and the Ontario Ministry of Natural Resources and Forestry with the Conservation Authority working under a third party arrangement. Chatham-Kent is not part of the agreement but certainly participates by hosting the gauge and maintaining the property. Under the agreement, Water Survey is responsible for maintenance of the gauge. By the afternoon of April 8th, Water Survey had the gauge back in operation. The only outstanding repair for the gauge itself is a water temperature sensor.

This gauge is very important to the flood warning and management program for the Conservation Authority and the city of Chatham. There has been a gauge at this location since at least 1938 with some records going as far back as 1923. All the major Thames River flood events in the city of Chatham have been recorded at this gauge location. The long term record is very important and even today this gauge is a critical component of the flood warning and management system since observed water levels from the gauge are used in the operations of 6th Street Backwater Flood Control Dam.

iii. WATERSHED PLANNING

a. Thames River Clearwater Revival

Information on the Thames River Clearwater Revival and recent developments to be presented in a PowerPoint presentation by Jason Wintermute, Water Management Supervisor.

b. Cyanobacteria Working Group

Over the last few years, blue-green algae, cyanobacteria, and microcystins have been a major concern for the western and central basins of Lake Erie. In 2012, the Ontario Ministry of the Environment formed a Cyanobacteria Working Group to keep on top of the issue. Since that time, the Lower Thames Valley Conservation Authority has participated in the Working Group. Other participants include the Health Units, Drinking Water Plant operators and other Ministries. On April 16th, the Working Group held a teleconference to update all the parties with plans for the upcoming year. The Ontario Ministry of the Environment and Climate Change will continue its surveillance program this year. Measurements and sampling are conducted every 2 weeks from July to October unless conditions justify beginning earlier. They sample at 3 locations off the shore at Port Glasgow at depth of 4m, 12m and 19m. They sample at 2 locations off the western shore of Pelee Island. They also sample at 3 locations in Lake St. Clair; near the mouth of the Thames River, near the Stoney Point drinking water intake, and near Mitchell's Bay. Not only do they measure for actual algae mass and the presence of cyanobacteria and microcystins, but they are also measuring dissolved oxygen and temperature profiles to assist with predicting potential fish kills from hypoxia. In addition to regular water chemistry samples for nutrients, they have also started to take benthic samples as indicators of ecosystem health.

One objective of the surveillance program is to attempt to provide preliminary results of the monitoring to the Working Group Partners within 24 hours so that they can take any required actions and issue any required advisories.

There are several research studies being conducted into blue-green algae issues. Some relate particularly to drinking water systems and it is probably best to get that information through municipal sources. The Lake Erie Management Unit of the Ministry of Natural Resources and Forestry will be conducting a study on safe fish consumption during and after algae blooms. Another research study will be conducted in an attempt to determine the effects of the Thames River nutrient outputs on Lake St. Clair and Lake Erie.

The U.S. National Oceanic and Atmospheric Administration (NOAA) has a Harmful Algae Bloom website which is useful in tracking and predicting the blooms. http://oceanservice.noaa.gov/hazards/hab/
The Ontario Government has also created a 12 Point Plan on its own Blue-Green Algae website.

The Working Group would also like to remind the public that the local Health Units should be the lead agency in taking reports about observed blue-green algae blooms.

EASTERN DISTRICT CA'S

Sharon Creek Conservation Area - Tallgrass Prairie Prescribed Burn - April 14, 2015

A \$3,000 grant facilitated through Tallgrass Ontario allowed for the prescribed burn of the 7 acre tallgrass prairie at the Sharon Creek Conservation Area near Delaware. Seeding will follow within the week of the burn to improve the prairie. The \$1,500 of seed was funded through the Lower Thames Valley Conservation Foundation.

The Lower Thames Valley Conservation Authority (LTVCA) owns and manages the Sharon Creek Conservation Area located in the Municipality of Middlesex Centre at 4212 Springer Road. A 3.4 hectare (7 acre) Tallgrass prairie habitat is centrally located in the conservation area. Tallgrass prairies are a fire dependent ecosystem.

A "low complexity prescribed burn" of the Tallgrass prairie was conducted April 14, 2015 to mimic a natural disturbance of a fire dependent ecosystem in a safe, controlled and effective manner that will meet the specific objectives of the Prescribed Burn. This burn at Sharon Creek Conservation Area Tallgrass prairie was deliberately set to burn by a professional prescribed burn team as conditions are perfect to do so.

The major volume of smoke that was seen by residents and 402 drivers was in the upper atmosphere that lasted no longer than a minute as the flames reach their junction zones and collapse. Intermittent smoke impact in the lower landscape lasted as long as the ignition phase. The burn plan restricts burning under certain wind direction and wind speed that could impact local drivers or people who may have their windows open or laundry on the line.

The burn took place when the grass was 70% to 90% cured in mid to late spring. The desired results of the burn are to:

- Reduce the encroachment of shrubs (sumac) and other invasive plants
- Stimulate the growth of native prairie plants
- Remove accumulated litter and surface seed bank, volatilize nitrogen and blacken the soil, which warms the ground so that prairie plants can overtake exotics. By warming the soil, releasing nutrients and reducing the nitrogen content, fire effectively provides conditions that decrease the vitality of most invasive or exotic plants yet encourages native prairie grasses and forbs to grow.
- Enhance prairie plant seed production and improve the health of the prairie habitat
- Stimulate root development of prairies, enhance growth and sequesters carbon resulting in improved air quality

The burn was conducted by the company Wildfire Specialists Inc. A burn plan was developed by Karnerblue32 Consulting – Jack Chapman – a qualified individual certified by the Ontario Ministry of Natural Resource Forest Fire Management Program in cooperation with the LTVCA. Safety is the central focus when planning all prescribed burn operations. All Burn Team members are certified in their capacity of their positions to conduct the burn. Lindsay Bennett is the Land Stewardship Technician with the LTVCA and recently completed her first level of certification for prairie burns. She was able to assist the team and gained great hands-on experience. The burn plan was approved by the LTVCA and the Municipality of Middlesex Centre Fire Department and Delaware Fire Department.





A NOTICE prior to the burn was circulated to all neighbours and posted on the gate at the park entrance. Neighbours to east, south and west of the Sharon Creek Conservation Area were informed of the burn day in advance. The burn was viewed by the Delaware District Fire Chief as well.




Greening Partnership







Re: GM's Report

Since the Annual General Meeting, staff have focussed efforts on preparing for and initiating the 2015 work plan. A major initiative begun in 2014 is the expansion of the Greening Partnership in conjunction with Chatham-Kent to assist in fulfilling the newly adopted Natural Heritage Implementation Plan. The LTVCA is a key agent in delivering this program and the new program staff that joined us last year are keen and ready to make an impact.

Following another very cold winter, we were again treated to an ideal spring melt which quickly reduced chances of serious, ice-jam related flooding. Once again, preparations began early with meetings with local emergency response personnel and the ice management committee. With the arrival of spring, the focus of water management shifts to water quality monitoring of both surface and groundwater plus the addition of benthic biological monitoring which we were able to initiate in 2014.

Investigations of the environmental conditions at 112 Thames Street have been completed and we are awaiting results at this time. Should this matter proceed, we are planning to implement a low-impact demonstration site and reconfigure parking at our current location to improve safety and traffic flow.

Late last year the Board approved some much needed updates to the exterior of the Administration building and in conjunction with that, at the same time, modifications to the front entranceway and washrooms will be undertaken to meet our accessibility requirements and furnish some secure and badly needed storage space. It is anticipated that most of the work will be completed over the summer.

Staff have successfully pursued external funding for these projects and additional applications are in the works, reducing the impact on our resources while enabling the facilities to meet our needs for the near future. Currently, two staff are undertaking a WSIB course which when completed will qualify the Authority for a 5% reduction in its WSIB premiums.

Finance staff are undertaking a review of our utility and telephone accounts, with a view to achieving cost savings from consolidating or eliminating in some cases accounts which are under- or no longer being utilized. A future report on the impact of this will be provided to the Board.

Finally, eight Board members participated with staff in a Visioning exercise as part of the Strategic Planning process, and all members recently received a copy of the results. Your comments and ongoing input will be sought as we move through this process, to be completed later this summer.
