PURPOSE OF POSITION:

To provide support to LTVCA staff, assist with Conservation Area projects such as the building of an Ojibway Round House, Improve Accessibility of Conservation Areas through trail improvements, upgrades to structures such as the Ska-Nah-Doht palisade and heritage cabins in the Eastern District area of the Lower Thames Watershed. Participate in our LEAN culture and take part in LEAN activities related to Conservation Areas.

QUALIFICATIONS:

- Provide police clearance check
- High school diploma, college or university an asset
- Experience with basic grounds maintenance equipment
- Excellent communication skills, maintaining good public and personnel relations
- Able to deal with people sensitively, tactfully, diplomatically, and professionally at all times
- Current First Aid Certificate- Standard and CPR an asset
- Flexible, able to deal with change, ability to think outside the box
- Willingness to improve everyday
- Have a positive attitude, strong work ethic and positive team attitude
