- Use of power tools and will assist in repairs, renovations, and other minor projects. Your input will be encouraged and acknowledged.

- Assist in the maintenance of several different properties in the Eastern District of the Lower Thames Valley Conservation Authority. This includes grass maintenance and trail work.
